Challenges in the Indian Road Logistics Industry



Truck Drivers

Unprecedented shortage of truck drivers



INR 18,000 – INR 23,000

Monthly income with no job security

Globally Unique Driver Relay Model





- Pit stops separated by 200-250 kms
- Driver to driver changeover happens at the pit stop
- Technology, IOT and data based systems
 - Robust routing/queuing logic
 - Measurement of KPIs
 - Performance management and improvement of truck operations and practices

- 1. Every driver returns home the same day and leads a better life with health and safety
- 2. Truck operating time increases substantially which leads to higher efficiency and lower costs. Vehicle runs 22-23 hrs a day as opposed to 8-10 hrs for an average operator.
- 3. Better service offering for customers with lower 50-70% transit time



E-way Bill



- The e-way bill provisions in GST aim to remove the ills of the erstwhile way bill system prevailing under VAT in different states,
- This was a major contributor to the bottlenecks at the check posts.
 Moreover different states prescribed different e-way bill rules which made compliance difficult.
- The e-way bill provisions under GST will bring in a uniform e-way bill rule which will be applicable throughout the country.
- The physical interface will pave way for digital interface which will facilitate faster movement of goods.
- It is bound to improve the turnaround time of vehicles and help the logistics industry by increasing the average distances travelled, reducing the travel time as well as costs.

Ways to Generate E-Way Bill



Generation Method	Description	Limitations
Web portal	 Login to NIC portal, register and generate e-way bill Separate login for consignor and transporter 	 Login every time to generate each e-way bill Manual operation prone to mistakes
SMS	Use SMS	Difficult to type all data required
Bulk Upload	 Popular method used by many large shippers 	 Requires creation of JSON and then upload the same
API	 Automated generation and update of e-way bill 	 Requires IT team support and registration with GSP Charged for every call to NIC portal
